Mark Wynn

A 21 year member of Nashville Metropolitan Police Department serving as Lieutenant to Domestic Violence Division. He received the 2012 Family Justice Center Alliance Lifetime Achievement Award. In 2011, he was awarded the “Visionary Award” by End Violence Against Women International and the Distinguished Award by the National District Attorney’s Association. He is a member of the International Association of Chiefs of Police National Strategic Partnership on Violence Against Women, faculty member to the National Leadership Institute, and consultant to other federal and state agencies.
