**Memorandum of Agreement Template**  
Revised January 2023

This Memorandum of Agreement (MOA) is entered into by and between the Commonwealth of Kentucky, the Kentucky Opioid Abatement Advisory Commission (the **GRANTOR**) by and through the Kentucky Office of the Attorney General (OAG) and Revive Ministries (the **GRANTEE**) to establish an agreement for the **GRANTEE** to utilize opioid settlement funds. The initial MOA is effective from SEPTEMBER 1, 2023, through JUNE 30, 2024.

**Scope of GRANT AGREEMENT:**

The **GRANTEE** serves individuals diagnosed with opioid use disorder (OUD), or co-occurring substance use disorder (OUD/SUD), or other mental health issues (SUD/MH). The **GRANTEE** shall expand its current treatment programs through the Common Ground Resource Center (CGRC). The CGRC is located at 104 S. Second Street, Nicholasville, KY 40356.

The **GRANTEE** provides prevention, treatment, and support services to individuals and families impacted by opioid use disorder or co-occurring substance use disorder or mental health issues. The **GRANTEE** shall offer mental health services to individuals and families impacted by opioid use disorder, co-occurring substance use disorder, or mental health issues. These services shall include evidence-based mental health services provided by a qualified mental health provider, including Licensed Marriage and Family Therapists/Marriage and Family Therapist Associates (LMFT/MFTA); Licensed Clinical Professional Counselors/Licensed Professional Counselor Associates (LPCC/LPCA); Licensed Clinical Social Workers/Clinical Social Workers (LCSW/CSW); or Licensed Psychological Practitioners (LPP.) Additionally, the **GRANTEE** shall provide prevention education programs to adults which teach the dangers of opioids and other co-occurring substances, the impact opioid use may have when combined with psychiatric medications, and how to recognize problematic opioid use or co-occurring substance use. The **GRANTEE** shall provide prevention education programs to individuals under the age of eighteen (18) which will communicate the dangers of opioid use disorder or co-occurring substance use disorder. The **GRANTEE** shall provide prevention education to individuals under the age of eighteen (18) through the utilization of a specific curriculum entitled "Positivity Project (P2)." "Positivity Project (P2)" is a nationally recognized character building program developed for individuals under the age of eighteen (18) by The Positivity Project. The P2 curriculum focuses upon the development of twenty-four (24) individual character traits within individuals under the age of eighteen (18) with the goal producing healthy, self-sufficient individuals. The P2 curriculum is currently utilized in eight hundred thirty (830) schools in twenty (20) states.

The scope of this **GRANT AGREEMENT** shall be governed by all statutory and regulatory requirements, including KRS 15.291, KRS 15.293, KRS 15.295, KRS 17.160 and 40 KAR 9:010E. The Commission may deem any non-compliance from a **GRANTEE** as grounds to cancel the contact and recover any remaining unexpended funds and un-authorized expenditures.

1. The **GRANTEE's** Grant Application is incorporated into this agreement in whole. In the case of any conflict between the language of this **GRANT AGREEMENT** and the language of the Grant Application, the language of this **GRANT AGREEMENT** shall prevail.

2. This **GRANT AGREEMENT** shall not exceed **\$500,000** (five hundred thousand dollars).
3. The **GRANTEE** shall not sell or sign over its operation to any third party during the contract period, may not reapply for additional KYOAAC funds until the contract period has expired, must disclose all potential conflicts of interest, and acknowledges that additional awards are not guaranteed and shall be subject to a new application and review process for any awards beyond this agreement period.
4. The Goals and Objectives (A) and Expectation and Activities (B) to be accomplished through this **GRANT AGREEMENT** shall be as follows:

**Responsibilities of the GRANTEE:**

**A. Goals and Objectives**

1. The **GRANTEE** shall utilize funds to offer clinical, non-clinical, educational, and engaging services to promote healthy behaviors, habits, and relationships. The **GRANTEE** shall serve 75 participants who will be adults and/or children with a dual diagnosis of opioid use disorder and mental health issues (OUD/MH). All adult individuals participating in mental health services will also receive prevention education related to opioid use disorder. At least 40% of adult individuals participating in mental health services will complete their individualized treatment plan to reduce opioid use. All youth participants will receive opioid use disorder or co-occurring substance use disorder prevention education. At least 60% of youth participants will complete the Positivity Project (P2) curriculum. The "Positivity Project (P2)" is a nationally recognized character building program developed for individuals under the age of eighteen (18) by The Positivity Project. The P2 curriculum focuses upon the development of twenty-four (24) individual character traits within individuals under the age of eighteen (18) with the goal producing healthy, self-sufficient individuals. The P2 curriculum is currently utilized in eight hundred thirty (830) schools in twenty (20) states. At least 40% of participants utilizing employment services will obtain employment and maintain employment for at least 60 days. At least 30% of those seeking higher education will complete the Adult Education GED program within 12 months. At least 70% of those in need of housing assistance will be referred to affordable housing options and assisted in applying for services. At least 75% of those seeking food pantry assistance will receive a referral for employment, case management, budgeting, and other life skills building programs.
2. The **GRANTEE** shall serve 75 participants impacted by opioid use disorder or co-occurring substance use disorder or mental health issues (including individuals, family members and youth) in the first 12 months of operation. All participants who qualify for family services (family counseling/youth counseling), will participate in opioid use disorder or co-occurring substance use disorder prevention education programs. At least 10 participants will be youth

ages pre-k through 5th grade. At least 65 participants will receive referrals to external services with community partners.

3. The **GRANTEE** shall identify the unserved, underserved, and vulnerable individuals impacted by opioid use disorder or co-occurring substance use disorder or mental health issues in the targeted community.
4. The **GRANTEE** shall utilize its programs, including the Common Ground Resource Center, to engage with these individuals impacted by opioid use disorder or co-occurring substance use disorder or mental health issues and encourage them to consider treatment for opioid use disorder or co-occurring substance use disorder or mental health issues. The **GRANTEE** shall be open to the public to enter and request services. The **GRANTEE** is the only center in Jessamine County, Kentucky that will offer referral for basic needs and professional services.
5. The **GRANTEE** shall also provide mental health services for individuals impacted by opioid use disorder or co-occurring substance use disorder. These services shall include evidence-based mental health services provided by a qualified mental health provider including Licensed Marriage and Family Therapists/Marriage and Family Therapist Associates (LMFT/MFTA); Licensed Clinical Professional Counselors/Licensed Professional Counselor Associates (LPCC/LPCA); Licensed Clinical Social Workers/Clinical Social Workers (LCSW/CSW); or Licensed Psychological Practitioners (LPP.) These services shall also support the individuals and families impacted by opioid use disorder or co-occurring substance use disorder or mental health issues as they transition out of treatment and back to their community.

**B. Expectation and Activities:**

1. *The **GRANTEE** shall report quarterly the number of participants served with a qualifying dual diagnosis for opioid use disorder or any co-occurring substance use (OUD/SUD) disorder and mental health issue (OUD/MH).*
2. *The **GRANTEE** shall report quarterly the percentage of participants who complete their treatment plan goals.*
3. *The **GRANTEE** shall report quarterly the number of youths enrolled in and the percentage of youth who complete the Positivity Project curriculum.*
4. *The **GRANTEE** shall report quarterly the number of participants who obtain employment and maintain employment for at least 60 days.*
5. *The **GRANTEE** shall report quarterly the number of participants who are seeking higher education, and the number of participants who will complete the Adult Education GED program within 12 months.*
6. *The **GRANTEE** shall report quarterly the number of participants who are in need of housing assistance who are referred to affordable housing options and are assisted in applying for housing services.*

7. *The **GRANTEE** shall report quarterly the number of participants who are in need to food pantry assistance that have or will receive a referral for employment, case management, budgeting, or other life skills building programs.*
8. *The **GRANTEE** shall report quarterly the number of referrals made to community partners with the number of referrals for each community partner.*
9. *The **GRANTEE** shall provide a copy of its monthly and quarterly project assessments for the **GRANTOR's** review.*
10. *The **GRANTEE** shall report the number of additional clients it is able to recruit or assist due to the expenditure of grant funds.*
11. *The **GRANTEE** is expected to comply with all applicable laws and regulations, including the relevant components of KRS Chapter 15 and 40 KAR Chapter 9.*

C. **Utilization of Grant Funds:**

1. The **GRANTEE** agrees that only that portion of the **GRANTOR's** funds necessary for the completion of the project (as detailed herein) will be spent. Use of these funds is limited to the approved project and budget listed on this **GRANT AGREEMENT**. The **GRANTEE** shall immediately notify the **GRANTOR** of any unspent moneys.
2. No funds may be used for construction, renovation, or to secure any kind of permits related to construction or renovation.
1. The **GRANTEE** shall deposit or immediately transfer awarded funds to a trust account held only for the purpose of drawing down grant funds. All expenditures for this award shall be made directly from that account.
2. The awarded funds pursuant to the **GRANT AGREEMENT** shall not be co-mingled with any other funds, accounts, or monies under the **GRANTEE's** name. Any interest deriving from the account shall be considered program income and shall be attributed to the project.

D. **Assumption of Liability:**

To the extent permitted by Kentucky law, the **GRANTEE** shall indemnify and hold harmless the **GRANTOR** and all of its officers, agents, and employees from all suits, actions or claims of any character because of any injuries or damages received by any person, persons or property resulting from implementation of this project based upon this agreement.

### **Responsibilities of the GRANTOR**

**A. Reservation of GRANT Funding:**

The amount of this **GRANT AGREEMENT** shall be awarded under the **GRANTEE's** name from the **GRANTOR's** available trust funds designated for such activities.

**B. Monitoring Work:**

1. The **GRANTOR** reserves the right to inspect at will all documents and premises pertaining to the MOA. The **GRANTEE** shall provide electronic access to all documents pertaining to the MOA.
2. As part of the **GRANTOR**'s inspection, it shall notify the **GRANTEE** of any noncompliance as defined in 40 KAR 9:010E Section 6(1). The **GRANTEE** shall address any noncompliance within a timeframe of thirty (30) working days. Failure to acknowledge and address noncompliance within the stipulated timeframe may result in the forfeiture and recoupment of remaining grant funds, where applicable, and may result in the **GRANTEE** not being eligible for **GRANTOR** trust fund awards.
3. The **GRANTEE** shall maintain on-site the results of criminal background checks of employees pursuant to KRS 17.160 to be available upon request during site visits and shall report any background check to the **GRANTOR** with offenses other than minor traffic offenses.

**C. Non-Compliance:**

Noncompliance with the terms of the **GRANT AGREEMENT** is reportable to the Department of Law for determination as to whether further action is necessary to ensure compliance with opioid-related agreements.

**Changes to Agreement and Pricing**

**A. Changes to Agreement:**

Any proposed change to this **GRANT AGREEMENT** shall be in writing and signed by the authorized agents of the **GRANTEE** and the **GRANTOR**. Any change to this **GRANT AGREEMENT** must be expressly approved by the **GRANTOR** in writing.

**MOA/PSC Exception Standard Terms and Conditions  
Revised January 2023**

**Whereas**, the first party, the state agency, has concluded that either state personnel are not available to perform said function, or it would not be feasible to utilize state personnel to perform said function; and **Whereas**, the second party, the Contractor, is available and qualified to perform such function; and **Whereas**, for the abovementioned reasons, the state agency desires to avail itself of the services of the second party;

**NOW THEREFORE**, the following terms and conditions are applicable to this contract:

**1.00 Effective Date**

This contract is not effective until the Secretary of the Finance and Administration Cabinet or his authorized designee has approved the contract and until the contract has been submitted to the Legislative Research Commission, Government Contract Review Committee ("LRC"). However, in accordance with KRS 45A.700, contracts in aggregate amounts of \$10,000 or less are exempt from review by the committee and need only be filed with the committee within 30 days of their effective date for informational purposes.

KRS 45A.695(7) provides that payments on personal service contracts and memoranda of agreement shall not be authorized for services rendered after government contract review committee disapproval, unless the decision of the committee is overridden by the Secretary of the Finance and Administration Cabinet or agency head, if the agency has been granted delegation authority by the Secretary.

**2.00 LRC Policies**

**This section does not apply to governmental or quasi-governmental entities.**

Pursuant to KRS 45A.725, LRC has established policies which govern rates payable for certain professional services. These are located on the LRC webpage (<https://apps.legislature.ky.gov/moreinfo/Contracts/homepage.html>) and would impact any contract established under KRS 45A.690 et seq., where applicable.

**3.00 Choice of Law and Forum**

**This section does not apply to governmental or quasi-governmental entities.**

This contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. Any action brought against the Commonwealth on the contract, including but not limited to actions either for breach of contract or for enforcement of the contract, shall be brought in Franklin Circuit Court, Franklin County, Kentucky in accordance with KRS 45A.245.

**4.00 EEO Requirements**

**This section does not apply to governmental or quasi-governmental entities.**

The Equal Employment Opportunity Act of 1978 applies to All State government projects with an estimated value exceeding \$500,000. The contractor shall comply with all terms and conditions of the Act.

**5.00 Cancellation**

Both parties shall have the right to terminate and cancel this contract at any time not to exceed thirty (30) days' written notice served on the Contractor by registered or certified mail.

**6.00 Funding Out Provision**

The state agency may terminate this contract if funds are not appropriated to the contracting agency or are not otherwise available for the purpose of making payments without incurring any obligation for payment after the date of termination, regardless of the terms of the contract. The state agency shall provide the Contractor thirty (30) calendar days' written notice of termination of the contract due to lack of available funding.

**7.00 Reduction in Contract Worker Hours**

The Kentucky General Assembly may allow for a reduction in contract worker hours in conjunction with a budget balancing measure for some professional and non-professional service contracts. If under such authority the agency is required by Executive Order or otherwise to reduce contract hours, the agreement

will be reduced by the amount specified in that document. If the contract funding is reduced, then the scope of work related to the contract may also be reduced commensurate with the reduction in funding. This reduction of the scope shall be agreeable to both parties and shall not be considered a breach of contract.

**8.00 Authorized to do Business in Kentucky**

**This section does not apply to governmental or quasi-governmental entities.**

The Contractor affirms that it is properly authorized under the laws of the Commonwealth of Kentucky to conduct business in this state and will remain in good standing to do business in the Commonwealth of Kentucky for the duration of any contract awarded.

The Contractor shall maintain certification of authority to conduct business in the Commonwealth of Kentucky during the term of this contract. Such registration is obtained from the Secretary of State, who will also provide the certification thereof.

**Registration with the Secretary of State by a Foreign Entity**

Pursuant to KRS 45A.480(1)(b), an agency, department, office, or political subdivision of the Commonwealth of Kentucky shall not award a state contract to a person that is a foreign entity required by KRS 14A.9-010 to obtain a certificate of authority to transact business in the Commonwealth (“certificate”) from the Secretary of State under KRS 14A.9-030 unless the person produces the certificate within fourteen (14) days of the bid or proposal opening. Therefore, foreign entities should submit a copy of their certificate with their solicitation response. If the foreign entity is not required to obtain a certificate as provided in KRS 14A.9-010, the foreign entity should identify the applicable exception in its solicitation response. Foreign entity is defined within KRS 14A.1-070.

**For all foreign entities required to obtain a certificate of authority to transact business in the Commonwealth, if a copy of the certificate is not received by the contracting agency within the time frame identified above, the foreign entity’s solicitation response shall be deemed non-responsive or the awarded contract shall be cancelled.**

**9.00 Invoices for fees**

**This section does not apply to governmental or quasi-governmental entities.**

The Contractor shall maintain supporting documents to substantiate invoices and shall furnish same if required by state government.

**10.00 Travel expenses, if authorized**

**This section does not apply to governmental or quasi-governmental entities.**

The Contractor shall be paid for no travel expenses unless and except as specifically authorized by the specifications of this contract or authorized in advance and in writing by the Commonwealth. The Contractor shall maintain supporting documents that substantiate every claim for expenses and shall furnish same if requested by the Commonwealth.

**11.00 Other expenses, if authorized herein**

**This section does not apply to governmental or quasi-governmental entities.**

The Contractor shall be reimbursed for no other expenses of any kind, unless and except as specifically authorized within the specifications of this contract or authorized in advance and in writing by the Commonwealth.

If the reimbursement of such expenses is authorized, the reimbursement shall be only on an out-of-pocket basis. Request for payment of same shall be processed upon receipt from the Contractor of valid, itemized statements submitted periodically for payment at the time any fees are due. The Contractor shall maintain supporting documents that substantiate every claim for expenses and shall furnish same if requested by the Commonwealth.

**12.00 Purchasing and specifications**

**This section does not apply to governmental or quasi-governmental entities.**

The Contractor certifies that he/she will not attempt in any manner to influence any specifications to be restrictive in any way or respect nor will he/she attempt in any way to influence any purchasing of services, commodities or equipment by the Commonwealth of Kentucky. For the purpose of this paragraph and the following paragraph that pertains to conflict-of interest laws and principles, "he/she" is construed to mean "they" if more than one person is involved and if a firm, partnership, corporation, or other organization is involved, then "he/she" is construed to mean any person with an interest therein.

**13.00 Conflict-of-interest laws and principles**

**This section does not apply to governmental or quasi-governmental entities.**

The Contractor certifies that he/she is legally entitled to enter into this contract with the Commonwealth of Kentucky, and by holding and performing this contract, he/she will not be violating either any conflict of interest statute (KRS 45A.330-45A.340, 45A.990, 164.390), or KRS 11A.040 of the executive branch code of ethics, relating to the employment of former public servants.

**14.00 Campaign finance**

**This section does not apply to governmental or quasi-governmental entities.**

The Contractor certifies that neither he/she nor any member of his/her immediate family having an interest of 10% or more in any business entity involved in the performance of this contract, has contributed more than the amount specified in KRS 121.056(2), to the campaign of the gubernatorial candidate elected at the election last preceding the date of this contract. The Contractor further swears under the penalty of perjury, as provided by KRS 523.020, that neither he/she nor the company which he/she represents, has knowingly violated any provisions of the campaign finance laws of the Commonwealth, and that the award of a contract to him/her or the company which he/she represents will not violate any provisions of the campaign finance laws of the Commonwealth.

**15.00 Access to Records**

The state agency certifies that it is in compliance with the provisions of KRS 45A.695, "Access to contractor's books, documents, papers, records, or other evidence directly pertinent to the contract." The Contractor, as defined in KRS 45A.030, agrees that the contracting agency, the Finance and Administration Cabinet, the Auditor of Public Accounts, and the Legislative Research Commission, or their duly authorized representatives, shall have access to any books, documents, papers, records, or other evidence, which are directly pertinent to this agreement for the purpose of financial audit or program review. The Contractor also recognizes that any books, documents, papers, records, or other evidence, received during a financial audit or program review shall be subject to the Kentucky Open Records Act, KRS 61.870 to 61.884. Records and other prequalification information confidentially disclosed as part of the bid process shall not be deemed as directly pertinent to the agreement and shall be exempt from disclosure as provided in KRS 61.878(1)(c).

**16.00 Social security**

**This section does not apply to governmental or quasi-governmental entities.**

The parties are cognizant that the state is not liable for social security contributions, pursuant to 42 U.S. Code, section 418, relative to the compensation of the second party for this contract.

Any exceptions to this stipulation require an attachment or exhibit that explicitly addresses, and provides a basis for, payment of second party's social security contributions by the state, pursuant to 42 U.S. Code, section 418.

**17.00 Violation of tax and employment laws**

KRS 45A.485 requires the Contractor and all subcontractors performing work under the contract to reveal to the Commonwealth any final determination of a violation by the Contractor within the previous five (5) year period of the provisions of KRS chapters 136, 139, 141, 337, 338, 341, and 342. These statutes relate to corporate and utility tax, sales and use tax, income tax, wages and hours laws, occupational safety and health laws, unemployment insurance laws, and workers compensation insurance laws, respectively. Disclosure of any violations is required prior to the award of any state contract and throughout the duration the contract.

Failure to disclose violations, shall be grounds for the Commonwealth's disqualification of a contractor or subcontractor from eligibility for future state contracts for a period of two (2) years.

To comply with KRS 45A.485, the Contractor and all subcontractors performing work under this contract shall report any such final determination(s) of any violation(s) within the previous five (5) years to the Commonwealth by providing a list of the following information regarding any violation(s): (1) specific KRS violated, (2) date of any final determination of a violation, and (3) state agency which issued the final determination.

A list of any disclosures made prior to award of a contract shall be attached to the contract. The Contractor affirms that it has not violated any of the provisions of the above statutes within the previous five (5) year period, aside from violations explicitly disclosed and attached to this contract. Contractor further affirms that it will (1) communicate the above KRS 45A.485 disclosure requirements to any subcontractors and (2) disclose any subcontractor violations it becomes aware of to the Commonwealth.

**18.00 Discrimination**

This section applies only to contracts disbursing federal funds, in whole or part, when the terms for receiving those funds mandate its inclusion. Discrimination (because of race, religion, color, national origin, sex, sexual orientation, gender identity, age, or disability) is prohibited.
