- I. Call to order
- II. Roll call and introductions

- III. Review of minutes from April 27, 2020 meeting

She is working on a plan for nurses to see children under 14 within the same timeframe of 96 hours which is state law. We want to make sure nurses are well trained and will have CAC help. The Board of Nursing is looking into this training and wants to train within the state. Christie Penn ask who is examining children under 14 now. Dr. Sugarman explained that it depended on the time of day but most of the time it is CAC or the hospitals.
- VI. Partner Updates and Announcements
 - a. Alicia Miller stated that Fayette County referrals are down compared to last April. They are expecting numbers to go up when daycares open back up.

- b. Chelsea Harrod is expecting a rise at the end of June because of more doctor visits because of the kids getting sick. The family support team is very busy and are working 6 days a week.
- c. Christie Penn says check in calls are down to once a week. The annual conference will be all online and she will send the information out to sign up.
