We have received your request for audit of the Child Victims' Trust Fund, for year ending June 30, 2024. We are unable to perform the audit at this time. KRS 45.149, therefore, authorizes you to enter into a contract with a certified public accountant (CPA) for the audit. Please be aware that each year you are required to submit a written request to the APA prior to entering into or renewing a contract with a private certified public accounting (CPA) firm.

This authorization is contingent upon the contract's containing the following provisions:

- 1) The audit shall be performed in accordance with auditing standards generally accepted in the United States of America and the standards for financial and compliance audits contained in *Government Auditing Standards* (GAGAS), issued by the United States Government Accountability Office.
- 2) At the conclusion of the audit, one copy of the audit report, including the report on internal control and compliance and the management letter, if applicable, shall be sent to our office, the Attorney General, and the Legislative Research Commission.
- 3) Our office shall be allowed access to all working papers, including the audit program, prepared as part of the audit process.

Kentucky Child Victim's Trust Fund (CVTF) Internal Audit: Specialty License Plate

19Sep2024

An internal audit has been conducted for the 2024 Fiscal Year. The audit was performed to ensure that the receipts and disbursements correlated to the amount reported by the Transportation Cabinet. Also, the audit reviewed that these funds complied with KRS 186.164 (14).

CVTF received \$20,607.79 in specialty license plate fees for the 2024 Fiscal Year. This amount included deposits totaling \$14,720.00 (from October 2023 to July 2024) directly related to the purchase and renewal of the "I Care about Kids" licenses plates. In addition, the CVTF received \$5,887.79 of excess fees issued by the Transportation Cabinet.

These funds were electronically deposited by the Transportation Cabinet into the Child Victims' Trust Fund (Fund#6305). These funds were then transferred into the Child Victims Exploitation Board Fund (Fund #1368). These specialty plate funds contribute to the expenses incurred to fund child sexual abuse and exploitation prevention programs and fund private nonprofit or public organizations in the development or operation of child sexual abuse and exploitation prevention programs. FY 2024 Special Plate Audit Notes:

Previous audits mentioned a potential concern between stipulations in KRS 186.164 (14) and the KYOAG handling of the deposits into 6305 and the subsequent transfer to 1368 to make disbursements. In an email dated 15Nov2022, the KYOAG OAS procedures handling the deposits into 6305 and disbursements from 1368 have been approved by KYTC. Attached to this audit report is the email stating as such from James Westbay, CPA with KYTC.

Receipts

- Deposits into the Child Victims' Trust Fund (CVTF) from the Kentucky Transportation Cabinet (KYTC) during FY2024 totaled \$20,072.79. (Fund 6305)
 - o \$14,185 purchase and renewal fees
 - \$3,755 Jul 2023 (FY23 4th payment)
 - \$3,825 Oct 2023 (FY24 1st payment
 - \$3,365 Jan 2024 (FY24 2nd payment)
 - \$3,240 May 2024 (FY24 3rd payment)
 - o \$5,887.79 annual excess fees for FY24 deposited in June 2024
 - "Excess fees" occur when the registration fees sufficiently cover the KYTC administrative cost.
 - o \$20,072.79 reconciles with the spreadsheet received from KYOAG Office of Administrative Services (OAS).
- The deposit in July of 2023 was for FY23. The fourth payment for FY24 was received 15Jul2024 for \$4,290.
 - Total FY24 revenues are \$20,607.79.
 - These figures reconcile with the data received from the KYTC via email. (\$14,720 plus the excess fees of \$5887.79).
- Note: Only \$3,825 of KYTC funds had been deposited into Fund 6350 prior to the \$175,000 transfer.
- Other income sources include (but are not limited to): income tax donations, KECC donations, and miscellaneous donations.

Disbursements

- The Child Victims' Exploitation Board Fund (Fund 1368) board-approved expenditures totaled \$111,952.86 during FY2024.
 - \$175,000 was transferred from CVTF 6305 to the Child Exploitation Board Fund
 1368 for expenditures during FY2024.
 - Expenses were in accordance with the Child Abuse and Neglect Prevention Board by-laws and KRS 15.935

- Seven random disbursements were reviewed (covering 87% of the expenditures).
 All documentation was provided. No discrepancies were found.
- o The ending balance in Fund 1368 on 30Jun2024 was \$71,970.99.

Recommendation:

The victim plate application with KYTC dictates how funds can be spent. At present, allowed expenditures include:

- Fund private, non-profit, or public organizations in the development or operation of CSA and/or exploitation programs.
- Fund the cost of CSA medical exams not covered by insurance or Medicaid.
- Fund statewide CSA prevention education and awareness.

If it is an option, the Board may want to consider reviewing and potentially revising the stated stipulations for the specialty license plate funds. See page 17 for application.
