# **MINUTES**

## I. CALL TO ORDER

Chair Ingram called the Treatment and Recovery Subcommittee application review meeting to order at 10:01 a.m. on Wednesday, March 20, 2024.

1. February 13, 2024, Business Meeting Minutes
