Basic info

Omegle is an anonymous chat site where users are matched at random (within topics, if selected). There are two main modes, “text” for plain text-based chats, and “video” which allows the use of webcams.

Omegle does not have usernames, accounts, or registration. It does collect IP addresses, and also uses a cookie for identification.

ID cookies

In general, records can be searched based on an IP address and/or an ID cookie. It is best to include an ID cookie when requesting records if possible. A dynamic IP address can change between when an incident occurs and when a law enforcement officer becomes involved, and this can sometimes make it difficult to determine the IP address in use at the time of incident. Omegle's ID cookie is a random value stored on users' computers, and it remains constant unless the user deletes it. To find a user's ID cookie on their computer, you can visit: <http://omegle.com/id>. You must use the same browser which was used to access Omegle.

Legal process

Preservation requests are accepted from both domestic and foreign law enforcement agencies, but please send these requests by email only. Emergency requests for Omegle to voluntarily release records to law enforcement will be evaluated.

Each line in this file represents a chat which occurred on Omegle. They each contain the following info:

- * A timestamp, representing the time the chat began.
- * For each party in the chat:
 - * - IP address.
 - * - Port number. (May be omitted in some cases.) This is required by some ISPs to personally identify a subscriber, in addition to the IP and timestamp.
 - * - An ID cookie assigned by Omegle. (May be omitted in some cases.)

Please note that Omegle does not have accounts or registration. IP addresses and randomly-generated ID cookies are the only forms of identification used by the site.
