Pursuant to KRS 15.100(2), Executive Director, Bobby Stokes called the roll. After the roll was called, a quorum was announced, and the meeting was called to order. Bobby Stokes welcomed everyone to the PAC meeting held in conjunction with the 2024 Kentucky Prosecutors Conference. Bobby Stokes announced that Samantha Bracco would be taking on the role of human resource administrator.

Attorney General, Russell Coleman, welcomed all attendees and acknowledged their efforts in managing their diverse responsibilities. He addressed an incident which occurred in Hardin County outside the county attorney's office this week. He invited Jenny Oldham, the Hardin County Attorney, to provide further details on the incident.

Jenny Oldham, Hardin County Attorney, reported that a shooting occurred outside her office, witnessed by both pedestrians and staff. The victim was involved in an unreported domestic violence situation. She highlighted the need to improve how the system handles such victims and discussed potential improvements. She also requested prayers for the children and others who witnessed the incident.

Attorney General, Russell Coleman, initiated a discussion on the best practices and resources available. He invited suggestions for the Attorney General's office on how to enhance safety measures.

# **ADMINISTRATIVE**

Bobby Stokes directed the Council to review the meeting minutes from July 19<sup>th</sup>, 2024, PAC meeting for approval as well as the July 29<sup>th</sup> special meeting minutes, Margaret Daniels made a motion to approve July 19<sup>th</sup>, 2024, meeting minutes, the motion was seconded by Joe Ross, and passed by voice vote. Jackie Steele made a motion to approve July 29<sup>th</sup>, 2024, special meeting minutes, the motion was seconded by Rob Sanders, and passed by voice vote.

Bobby Stokes requested approval from the Council to restore Julie Cox's KHRIS access in her new position as Human Resource Director for the Unified Prosecutorial System. Stacy Tapke made a motion to approve restoring Julie Cox's KHRIS access, the motion was seconded by Jackie Steele, and passed by voice vote.

#### TRAINING UPDATE

Susan Blake announced that the 2024 Kentucky Prosecutors Conference will commence tomorrow. Registration will start at 8:00 AM EST, followed by the pre-conference at 9:00 AM EST, and the general session beginning at 12:20 PM EST. A reception will be held after the final session. She also confirmed that the contracts for the 2026 Kentucky Prosecutors Conference have been signed, as previously approved, and the event will take place in Lexington, Kentucky, utilizing the three approved hotels. Bobby Stokes thanked Susan Blake and Matt Moye for their dedicated efforts in organizing the 2024 Kentucky Prosecutors Conference.

#### RESOURCE PROSECUTOR UPDATE

Tom Lockridge reported that he has been collaborating with Herb McKee, Henderson County Attorney, on an upcoming hearing. He attended the Association of Government Attorneys and Capitol Litigation Conference, which he described as excellent, with highly informative speakers. He has already made several recommendations to Susan Blake for future speakers. Additionally, he is preparing for the 2024 Kentucky Prosecutors Conference, the Basic Training Conference, and the 2025 Kentucky Prosecutors Conference. He continues to assist several offices with their cases. Attorney General Russell Coleman congratulated him on receiving the NDAA award and the Alumni Award from Eastern Kentucky University and thanked him for his hard work.

Kathy Phillips, the domestic violence resource prosecutor, announced that she will be presenting at the Kentucky Emergency Nurse Association Conference on November 1st, focusing on the recognition and documentation of domestic violence and strangulation. She emphasized the importance of first responders understanding the dynamics of domestic violence, as many victims do not report these incidents when they visit hospitals. She is on a working group to develop best practices, training and protocols for Kentucky prosecutors handling domestic violence receiving

VAWA funding. Additionally, she is organizing a full-day domestic violence summit in Henderson County on October 23rd. Kathy continues to assist various offices with domestic violence cases.

Jenny True Reed, the Traffic Safety Resource Prosecutor, reported her recent visit to Maysville, where she presented on DUI Hot Topics and Medical Cannabis training. She expressed her gratitude to John and Claire Estill for their hospitality. She also announced upcoming DUI Hot Topics and Medical Cannabis training sessions scheduled in Adair County on September 25th and in Graves County on October 22nd. Additionally, she mentioned that the Cops in Court training will take place on September 27th in Danville. Furthermore, she will be holding a town hall with the Kentucky Hospital Associations to educate hospitals and hospital staff on performing blood draws when there is a search warrant or court order.

#### CASE MANAGEMENT UPDATE RFP

Alyssa Logan announced that, as previously reported, the finance cabinet has rejected the submitted SPR1. However, they have identified two potential companies already on state contract as alternatives. She received a demo from one of these companies, which she and Chad Coleman reviewed and subsequently sent to the committee for their evaluation. They plan to meet with a representative from this company tomorrow for a Q&A session. Alyssa reported that this company appears promising and can meet the non-negotiable requirements discussed. If the decision is made to proceed with this company, the previously submitted RFP will not be pursued further.

## PAC ROCKET DOCKET GRANT FINAL REPORT FY2025

Gina Carey directed the Council to the document located in the folders provided. She reported that the Rocket Docket is in its ninth year, and although the numbers are down, AOC's case filings show a 10 percent decrease in both district and circuit courts for FY24. The Rocket Docket has saved \$24 million this year and over \$200 million since the project's inception. Gina Carey requested a motion to approve the FY2025 PAC Rocket Docket recommended grant awards. Martin Hatfield made a motion to approve the recommended PAC Rocket Docket grant awards for FY2025, the motion was seconded by Rob Sanders, and passed by voice vote.

## **2024 SONEGO AWARD**

Rob Sanders made a motion to table the 2024 Sonego Award until the end of the meeting, the motion was seconded by Jackie Steele, and passed by voice vote.

#### PAC STAFF PAYROLL CERTIFICATIONS

Bobby Stokes directed the Council to review the July 31<sup>st</sup>, 2024, and August 15<sup>th</sup>, 2024, PAC/UPS payroll certifications in the folders provided for approval. Stacy Tapke made a motion to approve the

July 31<sup>st</sup>, 2024, and August 15<sup>th</sup>, 2024, PAC/UPS payroll certifications, the motion was seconded by Jackie Steele, and passed by voice vote.

# **BUDGET**

### **FY2025 UPDATE**

Gina Carey reported that it is still early in the fiscal year, making it too soon to predict the general fund budget accurately. However, she noted an increase in operating expenses for Commonwealth's Attorney's offices, alongside higher-than-expected vacancies. In contrast, the County Attorney's offices are performing as anticipated. She will continue to monitor the vacancies in the Commonwealth's Attorney's offices, expecting the number to rise as many offices undergo transitions.

#### **FY2025 PAC ROCKET DOCKET GRANT AWARDS**

Gina Carey reported that the cost to continue all the Rocket Docket grants was approximately \$4.4 million. For FY25, there were nine requests for expansion or new programs. Jackie Steele explained that the committee met last Tuesday to review both new and existing programs, noting that a few programs have low participation numbers. He announced Gina Carey will be sending out emails next week regarding Rocket Docket numbers and resource utilization. Several new Commonwealth's Attorney's offices will be coming on board this fall, some of which do not currently have Rocket Dockets but may be added later. Jackie Steele reported that the committee was able to approve four new programs in the following counties:

- 55<sup>th</sup>/Bullitt County- dedicated PT position
- 16<sup>th</sup>/Kenton- additional detective
- 40<sup>th</sup>/Clinton/Cumberland/Monroe- new program
- 9th/Hardin- increase County assistants to meet demand

Jackie Steele explained that in the 41st Judicial Circuit, Jackson County withdrew from receiving Rocket Docket funds, reducing the amount allocated to the 41st Judicial Circuit. He is hopeful that Rocket Docket funding can be addressed in the coming months once a new Commonwealth's Attorney is appointed. Gina Carey reported that 51 programs in 93 counties receive Rocket Docket funding, with a total projected cost of approximately \$4.6 million. John Estill made a motion to approve the 51 programs in 93 counties to receive Rocket Docket funding in FY25 for a total of approximately \$4.6 million. The motion was seconded by Courtney Baxter and passed by voice vote. Rob Sanders requested that the minutes reflect he abstained from participating in the vote.

## SALARY CLASSIFICATION AND COMPENSATION REQUESTS

and joy impacts everyone, radiating hope and positivity even in the most challenging situations. Angela's letter thanked and congratulated Jade on her hard work and dedication. Jade Morgan thanked everyone, expressing her love for her job and feeling fortunate to do what she does.

Bobby Stokes expressed that it is always a pleasure to recognize hard work and commendable individuals. He highlighted the joy in seeing the attributes that made lan Sonego great reflected in those who follow in his footsteps. He thanked both recipients for their dedication and hard work.

Gina Carey reported that the 14th and 41st Commonwealth's Attorneys' offices did not submit their salary classification and compensation reclassification. She requested the Council's approval to classify all employees in those offices as entry level for their respective positions. Rob Sanders made a motion to approve this designation, the motion was seconded by Margaret Daniels and passed by voice vote.
