**MOTION FOR PROTECTIVE ORDER**

The Plaintiff, Kentucky State Lodge Fraternal Order of Police (“FOP”), by counsel and pursuant to CR 26.03, hereby moves the Court to enter a Protective Order prohibiting Defendant Matthew G. Bevin (“Bevin”) from taking the deposition of the FOP in this matter. In support of this motion, Plaintiff states:

On April 30, 2018, Counsel for the Governor served the attached Notice of Deposition (Exhibit A) seeking to depose the FOP, through its representative(s), on May 9, regarding facts alleged in the Complaint. However, no facts appear to be in issue; instead, the questions to be resolved by the Court are purely legal. In these circumstances, discovery is neither necessary nor appropriate.

Moreover, the purpose of verifying the Complaint was to assure compliance with the requirements of CR 65 for immediate relief. But the issue of immediate relief is now moot in that

the Court is proceeding directly to the merits of the legal issues in the case. If an actual issue of material fact should present itself, the taking of depositions could be revisited. There is no purpose in depositions at present.

Following a status hearing on April 19, in which the Court did not entirely foreclose the possibility of discovery, but noted generally that it did not seem necessary at the time, this matter was set for an expedited briefing schedule with the Plaintiffs' first brief to be filed May 2. The schedule does not provide for discovery, and contemplates that the case is ready for resolution on the merits through briefing.

Upon a showing of good cause, the Court is empowered to issue protective orders under CR 26.03, limiting or prohibiting discovery "to protect a party or person from annoyance, embarrassment, oppression, or undue burden or expense." Deposition of an FOP representative is not reasonably calculated to lead to the discovery of admissible evidence, and would be unduly burdensome where there are no facts in dispute. In addition, the tight briefing schedule for motions regarding the merits of the case makes the taking of deposition impracticable in the short time frame available. For these reasons, the FOP respectfully submits that a protective order prohibiting the deposition is warranted.
