**Kentucky Child Victim's Trust Fund (CVTF)
Internal Audit: Specialty License Plate**

September 26, 2023

An internal audit has been conducted for the 2023 Fiscal Year. The audit was performed to ensure that the receipts and disbursements correlated to the amount reported by the Kentucky Transportation Cabinet (KYTC). In addition, the audit ensured that the funds were in compliance with KRS 186.164 (14).

The Child Victims' Trust Fund reported receipts of \$22,210 in specialty license plate fees for the 2023 Fiscal Year. This amount included \$15,240 directly related to the purchase and renewal of the "I Care about Kids" license plates and \$6,970 of annual excess fees issued by the Transportation Cabinet.

These funds were electronically deposited by the KYTC into the Child Victims' Trust Fund (Fund#6305). A portion of these funds were then transferred into the Child Victim's Exploitation Board Fund (Fund #1368) in order to fund child sexual abuse and exploitation prevention programs, fund the cost of CSA medical exams not covered by insurance or Medicaid, and fund private nonprofit or public organizations in the development or operation of child sexual abuse and exploitation prevention programs. The remaining balance will be transferred to the Child Victim's Exploitation Board Fund at a later date to be utilized in accordance with KRS 186.164 (14).

FY 2023 Special Plate Audit Notes:

- The Child Victims’ Trust Fund receives money from two separate Kentucky Transportation Cabinet (KYTC) sections, Motor Vehicle Licensing and the Budget Office.
 - KYTC MVL remits fees quarterly via a JV2R for the issuance/renewal of the “I Care About Kids” license plates and the Budget Office remits the excess fees annually.
 - The remittances from KYTC correspond to the deposits into the Child Victims’ Trust Fund.
- Deposits into the Child Victims’ Trust Fund during FY 2023 totaled \$22,210.
 - \$15,240-purchase and renewal fees
 - 07/12/2022-\$4,090 (Purchase/Renewals from Q4-FY 2022)
 - 10/13/2022-\$4,275 (Purchase/Renewals from Q1-FY 2023)

 - 04/06/2023-\$3,535 (Purchase/Renewals from Q3-FY 2023)
 - \$6,970-annual excess fees for FY 2023 was deposited on 6/30/2023

 - *Timing difference likely explains the difference between the \$14,565 from renewals/issuance and the KYTC transfers of \$14,905 related to FY 2023. The KYTC transfer date was 7/14/2023.

- The Child Victims Exploitation Board Fund (1368) board-approved expenditures totaled \$180,822.89 during FY 2023.
 - \$175,000 had been transferred from the Child Victims Trust Fund (6305) to the Child Victims Exploitation Board Fund (1368) for expenditure during FY 2023.
 - Expenses were in accordance of the Boards by-laws and KRS 15.905.

 - Ten random expenses were reviewed and all supporting documentation was provided.
- Expenses related to the purpose of the “I Care About Kids” license plates creation exceeded the \$22,210 received from KYTC for FY 2023.
 - Note: Only \$4,090 of KYTC funds had been deposited in FY 23 prior to the \$175,000 transfer.

FY 2023 Special Plate Audit Notes:

• **Recommendations to the Board:**

- Recommend that the monies received from KYTC be deposited into the Child Victims Exploitation Board Fund (1368) separately from other donation sources. This will allow for better tracking and accountability of expenditures related to KYTC funds.

- Basis for recommendation-KRS 186.164:

(13) The group shall, at the time the nine hundred (900) applications are submitted to the Transportation Cabinet, also submit a notarized affidavit to the cabinet attesting to:

(a) The name, address, and telephone number for the group or organization. If the group or organization does not have its headquarters in the Commonwealth, then the name, address, and telephone number for the group or organization's Kentucky state chapter shall be required. The names of the officers of the group or organization shall also be required. If the entity receiving funds under subsection (12) of this section is not a state governmental agency, a program unit within a state governmental agency, or is a group or organization that does not have a statewide chapter, then a donation for use by the group or organization shall be prohibited;

(b) The amount of the monetary donation the group wants to receive when a person purchases the group or organization's special license plate; and

(c) The purpose for which the donated funds will be used by the group or organization. *Donated funds shall not be limited for use by members of the group or organization, and shall not be used for administrative or personnel costs of the group or organization.*

(14) All funds received by a group or organization under subsection (12) of this section shall be deposited into an account separate from all other accounts the group or organization may have, and the account shall be audited yearly at the expense of the group or organization. The completed audit shall be forwarded to the Transportation Cabinet in Frankfort. *One hundred percent (100%) of the funds received by a group or organization under subsection (12) of this section shall be used for the express purpose identified by the group in subsection (13) of this section.* Any group or organization that receives a mandatory EF fee under KRS 186.162 shall comply with the provisions of this subsection.

We have received your request for audit of the Child Victims Trust Fund (CVTF), for year ending June 30, 2023. We are unable to perform the audit at this time. KRS 45.149, therefore, authorizes you to enter into a contract with a certified public accountant (CPA) for the audit. Please be aware that each year you are required to submit a written request to the APA prior to entering into or renewing a contract with a private certified public accounting (CPA) firm.

This authorization is contingent upon the contract's containing the following provisions:

- 1) The audit shall be performed in accordance with auditing standards generally accepted in the United States of America and the standards for financial and compliance audits contained in *Government Auditing Standards* (GAGAS), issued by the United States Government Accountability Office.
- 2) At the conclusion of the audit, one copy of the audit report, including the report on internal control and compliance and the management letter, if applicable, shall be sent to our office, the Attorney General, and the Legislative Research Commission.
- 3) Our office shall be allowed access to all working papers, including the audit program, prepared as part of the audit process.
